### **\*NOTE:**

1. The Krugersdorp Flying Club, a non-profit organisation, (KFC) wears three hats:
  - 1.1 Most importantly, it is the Airfield Licensee (Operator) in terms of the Aviation Act.
  - 1.2 It is the Lessee of the Airfield (this is disputed by some parties).
  - 1.3 It is a body of like-minded people who have an interest in aviation.The Krugersdorp Flying Club, as Licensee and "Operator", has a duty, in terms of the Act, to enforce rules. In terms of those rules, it levies fees on all users of the Airfield (including non-KFC members). The proceeds of all fees are employed in maintaining, improving and defending the airfield.
2. A person may only enjoy Student Membership status if he/she is not a licensed pilot (and does not own an aircraft) and is undergoing training at one of the flying schools located on the airfield.

STUDENT MEMBERS are NOT full members. Student members enjoy a special status in that they may use the airfield and club facilities, without having to pay the Entrance Fee or be formally proposed to the Committee.

Student and Flight Schools use the airport facilities (runways etc.) which are paid for and maintained by the members. Accordingly, membership is compulsory when a candidate commences training with one of the flying schools located on the airfield.

Student membership automatically lapses after one year. Normal application procedures apply for becoming a full member once training is complete. A student member qualifies for full membership after obtaining a license without paying an entrance fee provided his/her student membership has not lapsed.

3. The Club reserves the right of admission at all times.
4. Club rules require that ALL full membership Applicants be introduced to the Club by their Proposer, in person, at a Club meeting. These meetings are held in the Clubhouse every second Wednesday of the month at 19:30(B).
